DESCRIPTION OF COURSE:

This course will examine representative works of Shakespeare, concentrating on a critical/analytical approach to the plays.. Emphasis will also be placed upon Renaissance/Elizabethan dramaturgy and conventions; language and style and the human experience represented in Shakespeare's histories, comedies, romances, and tragedies.

LEARNING OUTCOMES:

- Students will read, comprehend, and understand Early Modern English in Shakespeare's work
- Students will demonstrate critical analysis of Shakespeare's work through a variety of methods including close reading and explication as well as in the context of contemporary literary theory.
- Students will demonstrate an understanding of the conventions of Early Modern Poetry and of the Elizabethan Sonnet form.
- Students will demonstrate an understanding of Shakespeare's work in its historical, social, and cultural contexts
- Students will demonstrate an understanding of how research is conducted and presented in the field of English Literature.
- Students will conduct research based literary analysis.
- Students will demonstrate an understanding of Early Modern conventions of drama.
- Students will demonstrate basic understanding of the common elements of History, Comedy, Romance, and Tragedy in terms of Shakespearean/Elizabethan application.

GENERAL INSTRUCTIONAL METHODS:

ASSESSMENT:

- 20% Reading Responses: 300-500 word critical readings of the literature presented in each unit. Reading responses often ask students to incorporate a variety of additional readings, including secondary sources, in their analyses of the literature.
- 20% Mid Term Examination: Identification questions, short answer questions, and an essay question.

- 20% Long paper / project: This project will take up a topic selected by the student and approved by the instructor. It will require the use of at least three secondary sources, which will be documented appropriately in a documentation format agreed upon by the instructor and the student.
- 20% Final Examination: This cumulative exam will consist of identification questions, short answer questions, and an essay question.
