- 2) Minutes from September 25, 2015 meeting (Approved)
- 3) Testing Center/Lock-down Respondus/Secure Exam Replacement (Digital Learning/Instructional Success, Michelle Teasley) (Possibly moved to next month for details, but we don't really have a choice). Plan is to pilot Respondus starting 11/1/15. Need to replace secure exam.
- 4) General Education Course Review Process (General Education Task Force, Steven George)
  - a. Define gen ed courses. Look at TAGs.
  - b. Created quick reference guide of OBOR standards
  - c. If creating a new Gen Ed course, whether A&S or C&T, need A&S approval, need to apply per instructions.
  - d. Email sent to all faculty asking for feedback by 11/4/15
  - e. Will vote in 11/20/15 meeting
- 5) Student Evaluations (Instructional Success) Presenting a new student eval
  - a. Looking at more pointed questions to determine teaching effectiveness. (Mark recommends reading the research if you have nothing to do.)
  - b. Discussed wording of some of the questions, but more wording changes could be possible.
  - c. PLAN Committee members send wording/question suggestions to Mark and Sue Donahue by 11/13/15, and will be discussed in 11/20/15 meeting.
- 6) Placement of the College Credit Plus policy within the Policy and Procedures (Academic Rules and Policies Committee) Have a suggestion on where to place this in handbook. Place 5-05 academic courses and credit (Motion/second Christine Creagh/Jack McCoy). Approved.
- 7) Delaware OAA Committee (Benjamin Pugno and Nancy Pine, Delaware Campus Faculty)
  - a. Committee started 2010. Campus growing (1700 students), but losing resources. Want to join OAA to have a voice. And Dr. Cooley approved concept of adding.
  - b. Vote to add Delaware Campus Faculty Committee to OAA committees; recognizing structure could be different than others (ie: only A&S as co-chairs, changing balance of OAA chair group). (Motion/Second Julie Cronk/Gilberto Serrano) Approved.
- 8) Competency-Based Task Force--Follow-Up (Academic Pathways)
  - a. Request from Dr. Cooley to look into this. Patricia Allen is collecting names for this task force. (Adding Lauren Jones). Still need more volunteers.
- 9) Eight-Week Semester Follow-Up (Eight-Week Semester Task Force)
  - a. Still need more volunteers.
  - b. Some volunteered for task force last meeting. Action not started yet.
- 10) Pathways Grant Proposal (Academic Pathways Committee)
  - a. Pathways grant. We want to be a forerunner school.
  - b. Wide variety of student success initiatives possibly involved. Veterans, college credit plus, at-risk, first generation, etc.
- 11) Drop for non-payment (Welcome to Martin Maloweski and Aletha Shipley)
  - a. Presented to cabinet SP15 and had large conversation about dates, fees, and how strict

- b. Fewer being dropped in AU15 (4283) vs AU14 (6308), partly since 3000 were protected.
- c. Created a "protected" six groups Protected from being dropped. Not getting charged late fee About 3000 students Financial aid students, veterans, college credit plus, sponsored party, fin aid consortium, payment deferral option.
- d. New: Payment deferral option (Already have a payment plan option, which is very structured and \$15 enrollment fee) This one has \$115 enrollment fee.
- e. FYI: For AU15 semester: Census date had around 25,000 headcount
- f. Drop dates Five days before start, 14<sup>th</sup> census day for second drop.
- g. Late fees Ongoing debate and discussion during meeting.
- h. Feedback from group: Keep looking at fairness. Communication and research tbd. Dates and fee amount could be considered.
