BOARD OF TRUSTEES MEETING Mitchell Hall | Crane Room (2nd Floor) Thursday, November 17, 2022 | 6:00 PM

CALL TO ORDER:

The Columbus State Community College Board of Trustees meeting was held on Thursday, November 17, 2022, in the second floor Crane Room at Mitchell Hall. The meeting was called to order by Vice Chair James Fowler at 6:00 p.m.

President Harrison advised that the record should show that notice of this meeting has been given in accordance with provisions of Section 121.22(F) of the Ohio Revised Code.

OPENING REMARKS

Vice Chair Fowler shared that the Board of Trustees had completed President Harrison's annual performance review. On behalf of the board, Vice Chair Fowler expressed "tremendous confidence" in President Harrison's leadership and service to the college and broader community.

President Harrison introduced Stephanie Knotts, student ex-officio, to share her Columbus State story. Ms. Knotts described her life's experiences and said that Columbus State offered the flexibility and affordability that allowed her to access higher education and succeed. She has made the Dean's List

every semester and is heavily involved on campus, including as an active member of Phi Theta Kappa Honor Society and the National Society of Leadership and Success. Ms. Knotts will graduate from Columbus State in Spring 2023 and plans to transfer to The Ohio State University to finish her undergraduate degree and eventually obtain a master's degree in social work.

President Harrison then introduced the Columbus State team that recently placed third in the Community College Innovation Challenge, a student competition sponsored by the National Science Foundation and National Association of Community Colleges. The team of Ms. Adina Beaufort, Mr. Bryce Byington and Mr. Ben Fisher worked on a project to use augmented reality to enhance hands-on learning, providing better outcomes and retention rates. The team was supported by Mr. David Cofer, Director of Partnerships and Programs; Mr. Chris Dennis, Assistant Professor of Engineering Technology; and Ms. Kaylor Sines, Supervisor in the Office of Talent Strategy.

President Harrison introduced Mr. Rob Messinger, who recently began as Chief of Staff in the Office of the President. Mr. Messinger joins the college from The Ohio State University, where he served in multiple leadership and communication roles, including serving the Chief Financial Officer, the Provost, and presidential initiatives.

APPROVAL OF REVISIONS TO CAPITAL EXPENDITURES POLICY 9-02:

Policy 9-02 was last updated in 2005. The proposed revision adds language to address the approval of overages on capital expenditure estimates that have been approved by the Board of Trustees. The proposed revisions include a general cleanup of the policy language and removes redundant language. Procedures related to the policy have been updated and will be implemented subsequent to the Board of Trustees approval of the revised policy.

President Harrison noted that this action item had been moved from the consent agenda to add a materiality threshold clause to the policy after discussion at the November 2022 Committee of the

PRESIDENT'S REPORT:

President Harrison shared several recent highlights with the Board of Trustees and, with members of his leadership team, provided updates about Columbus State enrollment for Autumn Semester 2022, evidence of K-12 learning loss during the pandemic and information about the first cohort of Columbus Promise students.

Recent highlights

- Student success stories in the news: The college was featured in several recent articles in The Columbus Dispatch that highlight Columbus State's focus on student success. On Nov. 13, the newspaper reported the strong start of the Columbus Promise program. A Nov. 15 story focused on the "Reconnect to Complete" program, which enables students who have paused their education to return to college to complete their degree.
- Honda and workforce development: Columbus State was one of three higher education institutions invited to participate in an announcement by Honda, LG Energy Solution and JobsOhio about a \$4 billion investment to manufacture electric vehicles in Ohio and build a battery plant in Fayette County. The investments will create 2500+ jobs. President Harrison noted that Columbus State is contributing to statewide workforce-development efforts.
- Serving military families: Chancellor Randy Gardner of the Ohio Department of Higher Education recently recognized Columbus State with the Collegiate Purple Star Award, which is awarded to schools that demonstrate a significant commitment to students and families connected to our nation's military. Columbus State has more than 1,000 military members and veterans among our students, faculty and staff.

- **Leadership development**: As part of Columbus State's commitment to the next generation of leaders, the college recently hosted the ACE Women's Network-Ohio conference, which offers professional development and networking opportunities to women in higher education.
- Supporting student voting: The national nonpartisan group ALL IN named Columbus State a "most engaged campus for college student voting." President Harrison thanked Jonathan Kreger, a Professor of Political Science, and Diana Wisse, Senior Director of Student Affairs, for their efforts in supporting voter engagement work.
- **Board engagement with students:** President Harrison thanked Vice Chair Fowler, who will be a speaker at an early December leadership workshop designed for business technology students. President Harrison expressed gratitude that Board members are so willing to share their expertise, wisdom, and leadership with students.

Autumn Enrollment Report

Mr. Allen Kraus, Associate Vice President of Enrollment Management & Marketing and Communications, shared that 25,272 students were enrolled in autumn 2022 for a total of 195,159 credit-hours. Mr. Kraus described enrollment trends for all students, traditional undergraduates and high school students enrolled in College Credit Plus. The college continues to experience strong enrollment in College Credit Plus, which now represents 28% of total headcount enrollment.

Learning Loss

Mr. Kraus and Dr. Rebecca Butler, Executive Vice President, shared information that further details the learning loss experienced by K-12 students during the pandemic and discussed how those trends would affect college readiness levels among incoming Columbus State students in years to come. The college will continue to respond to the situation by adapting programming and support services.

College Promise

Dr. Desiree Polk-Bland, Vice President of Student Affairs, updated the Board on the Columbus Promise program, which allows Columbus City Schools graduates to attend Columbus State at no cost to the student. The inaugural cohort, which started in autumn semester 2022, includes 629 students from 20 Columbus City Schools. Students can participate for up to six semesters.

Dr. Polk-Bland described the demographics, enrollment levels and other details of the first cohort. Columbus State has established a team of advisors, coaches, counselors and others who provide a suite of services to support their success. President Harrison said that Columbus Promise represents the college's largest-ever student success initiative.
