REPORT OF INDEPENDENT AUDITORS ON THE FINANCIAL STATEMENTS FOR THE YEAR ENDED JUNE 30, 2021:

Dr. Harrison introduced Ms. Aletha Shipley, Senior Vice President and Chief Financial Officer, who leads the audit process. Ms. Shipley introduced Mr. David Minich, CPA, Plattenburg and Associates, who provided information about himself and the firm and then provided an overview of the audit results.

He stated that the College received an unmodified opinion which is the best rating an institution can receive. He thanked the College's finance department and commented on the complexity of the audit this year given the issuing of debt, the HEERF funds, and working remotely this year.

Ms. Shipley's update included gratitude to the various departments who contributed to the Audit.

Ms. Jan Ellis, Executive Director, Office of the Controller, presented on the College's Fiscal Year 2021 Audit results. Highlights from her remarks included:

- -FY21 Comparison to FY20 with GASB 68 and 75
- -FY21 Comparison to FY20 without GASB 68 and 75
- -FY21 Highlights
- -Reserve Spending Analysis

In closing, Dr. Harrison, Member Joseph and Chair Burger all gave their kudos to the Business Services and Finance team for not only the clean audit, but also all the other work that this team continues to do all while managing many other major college initiatives.

The Committee of the Whole agreed to refer this item to the Board of Trustees for approval.

<u>APPROVAL OF ALTERNATIVE TAX BUDGET INFORMATION</u>:

Ms. Shipley stated that this is the first step that the County uses in planning for the year ahead for their budget process. The County puts out what their initial estimates are that would be our tax revenue that are aligned with what we have reported our debt service needs would be for the next year. This is required around January 20.

There is a recommendation for approval for this resolution for calendar year 2023.

The Committee of the Whole agreed to refer this item to the Board of Trustees for approval.

Dr. Harrison explained that the Board will be using a consent agenda moving forward. He went on to note that the consent agenda will help streamline Board of Trustees meetings, providing additional opportunity for deeper engagement.
