College Credit Plus Benefits

- Students can take Columbus State classes and earn both high school credit to satisfy graduation requirements.
- College credit that will be on their Columbus State transcript.
- Many Columbus State courses transfer to any public college or university in Ohio, and also transfer to many private institutions, as well.
- Students have the opportunity to earn their Associates Degree
 - Science
 - Arts
 - With a focus on Bio, Psychology, Communication

What to expect from your advisor

- Clearly communicate about college, major & curriculum, graduation requirements, CSCC's policies and procedures, and student services.
- Answer your questions in over the phone, video chat, and via e-mail
- Listen to your concerns and maintain your privacy.
- Assist you in working with your professors and refer you to college resources as needed (e.g. Tutoring or Disability Services).
- Show you where to find this information from the CSCC website.

What your advisor expects from you

- Check your CSCC email daily.
- Know about CSCC's policies and procedures as they relate to you.
- Know about your Program of Study/Major, your degree requirements, and your department.
- Schedule and keep regular advising appointments so you can keep track of your academic progress.
- Be prepared for advising sessions.
- Ask questions when you need more information or clarification.
- Take an active role in planning your education program.
- Take responsibility for the decisions you make regarding your academic progress and success.
- Keep a record of your academic progress that you can easily access and use; know how to use a Degree Audit Report.

Where to take Classes

- College Credit Plus can be offered in 3 different forms currently.
 - Embedded
 - Courses that are taken at your high school
 - Online Anytime
 - Courses that will be held online only—log-in at any time
 - Live online
 - Virtual face to face—specified required log-in time

Registration Form

Must be completed whenever you want to add a course that is online or on campus to your schedule. College Credit Plus students cannot register themselves. All signatures required

Consent Form

Must be completed every academic year (summer starts the new academic year). This form lists some of the policies and risks of taking College Credit Plus courses. You must have this form turned in before being able to register for courses. All signatures required.

Drop Form

Must be completed if you decide to drop a College Credit Plus class during the current semester. All signatures required.
