| WEB Online Technology (OT) Example: ENGL-1100-W01 | Your instructor will provide online course content via Blackboard and the Web, and there will be set due dates for assignments.* | Assessments must be completed by set due dates and will be online. These may require proctoring software.* | No. Your coursework and assessments will be completely online. | Section # will include a W. Instructional Method column will include Online Technology (OT) and WILL NOT include On-Campus Assessments (OA), or Virtual Assessments (VA). No days or times listed. |

If you live outside the region, you may request to use a local testing center or (depending on the class) a virtual assessment. | Section # will include a W. | WEB Online Technology (OT) Plus Periodic Live Online Classes MATH-1123-W02L-68980 On Campus Assessments | Your instructor will provide course content via Blackboard and the Web, and there will be set due dates for assignments. You will also attend periodic virtual class meetings.* | Assessments will be held at scheduled times on campus (OA) and/or virtually (VA). Virtual Assessments may require proctoring software.* | If your section has On-Campus Assessments you will come to campus for tests. If you live outside the region, you may request to use a local testing center or (depending on the class) a virtual assessment. | Section # will include a W and an L. Instructional Method column will include Online Technology (OT) and Live Online (LO), and might include On-Campus Assessments (OA) and/or Virtual Assessments (VA). |
| WEB Live Online (LO) Example: BIO-0100-W03L | Attend online class meetings through Blackboard, Teams, or Zoom, and complete assignments outside of class.* | Assessments will be online during scheduled class time or by an assigned due date, and may be conducted using proctoring software.* | No. Your coursework and assessments will be completely online. | Section # will include a W and an L. Instructional Method column will include Live Online (LO). Will have days and times listed. |
| BLENDED Online Technology (OT) and In Person Example: ART-1206-B01 | Complete 50% or more of the course content through assignments posted on Blackboard or the Web.* Attend on-campus class meetings. Complete online coursework by set due dates.* | Assessments held during scheduled class meetings or completed online by a due date. Virtual Assessments may require proctoring software.* | Yes. You will have to come to campus for scheduled in-person classes as listed in the section listing. | Section # will include a B. Will have days and times listed. |
| BLENDED Online Technology (OT), Live Online (LO), and In Person Example: MKTG-1100-B02L | Complete most course content at virtual class meetings or on Blackboard by assigned due dates.* Attend in-person labs or clinicals. | Assessments held during scheduled class meetings or completed online by assigned due date. Virtual Assessments may require proctoring software.* | Yes. You will have to come to campus for scheduled in-person classes as listed in the section listing. | Section # will include a B and an L. Will have days and times listed for live online and on campus classes. |
