Annual Eligibility Notice for the 403(b) Plan

Did you know Columbus State Community College offers a 403(b) tax deferred plan?

You may have the opportunity to save for retirement by participating in the Columbus State Community College's 403(b) supplemental retirement plan. Employees (with the exception of Student employees) are eligible to participate in the plan. You can participate in the 403(b) plan by electing to make pre-tax contributions and/or Roth 403(b) after-tax contributions.

What do you have to do to contribute to the 403(b) plan?

To start your contributions, establish an account with one of the approved participating investment providers. A list of the 403(b) participating investment providers is included. Once the account is set up with the vendor, initiate a Supplemental Retirement Plan Change event in Workday self-service. The 403(b) plan is administered by a third party administrator, Voya Plan with Ease.

Already contributing to the 403(b) plan?

If you are already contributing to the 403(b) plan, you may be able to increase your contributions. To change your contributions, initiate a Supplemental Retirement Plan Change event in Workday self-service.

How much can I contribute?

The contribution limit on elective deferrals in 2024 is \$23,000. Employees who are age 50 or over by the end of the calendar year can also make catch up contributions of \$7,500 in 2024 for a total of \$30,000. No employer contributions will be made.

Full-time and part-time employees may elect contributions as a percent of salary with a minimum of 5%.

Full-time employees may also elect contributions as a specific dollar amount with a minimum election of \$10.00.
